**Sec. 8834.051. DIRECTORS.** (a) The district is governed by a board of 17 directors appointed as provided by this section; (b) Directors serve two-year terms; (c) A director must be a qualified voter of the district; (i) Directors serve staggered terms.

**Sec. 8834.059. VACANCIES.** If a vacancy occurs on the board, the person or persons designated by Section 8834.051 to appoint a director for the position that is vacated, shall appoint a director to serve the unexpired term.
